#### 2024/25 Fiscal Year Internal Borrowing Rate

The Finance Committee took action to recommend to the Executive Committee and the Board of Directors to set the *internal borrowing rate for 2024/25 at 4.75%*.

#### **Return of PRISM ARC Additional Capital Contribution**

At their meeting on October 6, 2022, the Executive Committee approved contributing \$3.5M to ARC as additional paid in capital to replenish the ARC capital account to the minimum required amount of \$250k. At their meeting on October 16, 2023, the ARC Board took action to return the \$3.5M additional contribution to PRISM, which will be distributed back to the Programs in the same manner it was collected.

#### **General Administration Program Target Funding Guidelines**

The Committee approved the amendments to the General Administration (GA) Program Target Funding Guidelines. The amendment of the GA Program Target Funding Guidelines will change the amount reserved for deductibles from \$200,000 to two times the highest self-insured retention or deductible amount on any PRISM insurance policy – or \$500,000 for the 2024/25 fiscal year.

#### Extension of Independent Auditor Appointment

The Finance Committee approved the appointment of Gilbert CPAs as the Independent Auditor of PRISM and ARC for an additional 3 fiscal years.
