Committee Appointments

PRISM is fortunate to have a highly engaged membership, and we are truly appreciative of the time and effort given by the members. Appointments were made to the various PRISM Committees for positions whose terms were up and to fill vacancies. Of the *81 positions* to be filled, *19 will be by people new* to the Committee, and *15* were appointed to a committee *for the first time*. Across all Committees, *85 different entities* are represented and *112 individuals* are volunteering their time to serve.

Strategic Planning Retreat Recap

A recap of the Retreat discussions was provided in the agenda packet. From that, staff suggested adoption of 4 goals, supported by key initiatives, for inclusion in the Strategic Plan. The approved new goals are:

- PRISM takes a leadership role in building a consortium of industry leaders/trade organizations to bolster a career ladder for the risk management profession. (2-year goal)
- 2. Explore development of new JPAs as a mechanism for members to collectively serf-service in areas of critical need without desired vendor support (examples: claims administration and training, jail medical services. (3-year goal)
- PRISM will tighten standards and requirements of member participation with appropriate incentives for compliance and penalties for non-compliance, and deploy a comprehensive communication plan before implementation. (1-year goal)
- 4. Explore bringing Medical Malpractice Claims handling in-house. (1-year goal)

- Action was taken to increase PRISM's GL1 SIR to \$200k at renewal
